GENERAL TERMS AND CONDITIONS OF USE

The following general terms and conditions (“**Terms**”) form a legally binding agreement between You and Us in relation to Your access to, and use of, Microba and Your participation in any Research Project. By accessing or using Microba or participating in a Research Project, You acknowledge that You have read, understood and agree to be bound by these Terms. If You do not accept these Terms, You must not submit a Microbiome Request or participate in any Research Project, and You must refrain from otherwise accessing or using Microba. Please read these Terms carefully. By clicking “agree”, submitting a Microbiome Request or by otherwise using or accessing Microba, You agree to the following Terms.

Definitions for certain capitalised terms are set out at the end of these Terms.

ANY INFORMATION PROVIDED BY US (INCLUDING ANY INFORMATION CONTAINED ON OUR WEBSITE OR IN ANY MICROBIOME REPORT) IS FOR INFORMATION PURPOSES ONLY. SUCH INFORMATION IS NOT MEDICAL ADVICE AND MUST NOT BE TAKEN TO BE A SUBSTITUTE FOR A CONSULTATION WITH YOUR HEALTH CARE PROFESSIONAL OR DOCTOR. IT IS NOT INTENDED TO DIAGNOSE CONDITIONS NOR PRESCRIBE THE USE OF ANY REMEDY, DIET OR LIFESTYLE PRACTICE. YOUR HEALTH IS YOUR RESPONSIBILITY AND IF YOU HAVE ANY CONCERNS RELATED TO YOUR HEALTH WE RECOMMEND THAT YOU SEEK THE ADVICE OF YOUR HEALTH CARE PROFESSIONAL OR DOCTOR.

Eligibility

By participating in any Research Project or otherwise using Microba, You represent and warrant that You are at least 18 years old or that You have the permission of a parent or guardian if You are less than 18 years old. Parents and guardians of Users under the age of 18 must read and agree to be bound by these Terms and agree to be responsible for their child’s use of Microba (specifically the Microbiome Services). Where You provide Us with information in relation to Your child or children, You warrant that You are the legal guardian of Your child and have authority to provide this information to Us.

We may in our absolute discretion require certain additional consents to be provided by You (such as by executing certain consent documentation) (including in Your capacity as a parent or legal guardian of a User, if applicable) before we agree to provide any Microbiome Services or otherwise all You to participate in any Research Project.

Due to the nature of the Microbiome Services, We do not provide the Microbiome Services to infants younger than two years of age. We also reserve the right to decide at Our discretion for any reason to not provide the Microbiome Services to You by notifying You in writing.

If You are accepting these Terms on behalf of a company, organisation, association or agency as its authorised legal representative, then You represent and warrant that You have the power and authority to bind such company, organisation, association or agency to these Terms.

Registration

The use of Microbiome Services and/or participation in any Research Project may require You to register with Us and open an account. To do so, You must complete the registration process in the manner described on Our Website, or as otherwise notified by Us. We are not obliged to perform any Microbiome Services or provide You with a Microba Sample Kit unless you have opened an account. By registering with Us, You agree that all information You provide to Us (including any information set out in any Microbiome Request) is accurate and up to date and does not infringe any person’s rights. You must also update Your details if any of them change.

Registration is non-transferable. You are responsible for all of the activities that occur under Your account. You should carefully choose Your password and user name and protect them from unauthorised use. Please let Us know immediately of any unauthorised use of Your account or any other breach of security. We are not liable for any loss if someone else uses Your password or account.

Payment terms

Our provision of the Microbiome Services to You and/or Your participation in any Research Project may be subject to You paying Us certain Fees as set out by Us on the Website or as otherwise notified to You by Us. You acknowledge that the availability of any part or feature of Microba may be conditional upon the payment of such Fees.

You acknowledge and agree We may change Our Fees at any time. We will endeavour to notify You via the Website of any changes to the Fees before they come into effect, however this may not always be possible.

You acknowledge that Our performance of any part the Microbiome Services is conditional upon Us receiving the Fees in advance. We do not represent or guarantee that the Microbiome Services will be performed or completed within any specific timeframe. We will not be liable for any delay in the timely performance of the Microbiome Services.

If You do not accept the Fees or any changes to the Fees, You must not access or use Microba.

If You make any payments for Fees with a credit or charge card or an online payment account, You warrant that You are the cardholder or account holder and that the billing information provided is accurate, and You authorise Us to charge the designated credit or charge card or online payment account for the total amount of the Fees, plus any applicable GST. You acknowledge and agree that We may provide Your credit card information to third-party payment processors (such as Stripe) to enable Us to charge the designated credit card.

All payments and purchases made in connection with Microba are in Australian dollars and are non-refundable.

We may, at Our absolute discretion, agree to issue a refund to You where a request is made in writing. In these instances, You agree that We may, at our discretion, deduct a \$40 postage and handling fee from the amount of the refund.

Where applicable, You agree to pay all GST and other similar taxes imposed in connection with the supply of the Microbiome Services to You.

You are responsible for all internet service provider fees, telecommunication and other charges required for your connection to, or use of, Microba.

Subscriptions

From time to time, We may offer Users the opportunity to register for an ongoing subscription to the Microbiome Services (**Subscription**). Subscriptions may be offered for a fixed term or an ongoing basis. If You register for a Subscription, You authorise Us to charge Your credit card on a reoccurring basis depending on Your applicable Subscription period and the selected frequency of Microbiome Services. You may cancel Your Subscription at any time by sending an email to info@microba.com or by using the method for cancelling a subscription set out on Our Website. If You cancel Your Subscription:

- You are liable to pay all applicable Fees up to and including the day of cancellation;
- We are not obliged to provide any refunds, including for any remaining prepaid period in relation to the Subscription;
- Your rights and Our obligation to provide the Microbiome Services associated with Your Subscription will cease upon the expiry of the prepaid period applicable to that Subscription (if any); and
- You can re-subscribe at any time following the cancellation, however We reserve the right not to permit such re-subscription.

You may also request to amend Your Subscription at any time by sending an email to info@microba.com. Approval of any amendment requests will be at Our absolute discretion and may be subject to any reasonable conditions that We require.

We may cancel Your Subscription at any time by providing notice to You. If We cancel Your Subscription and You have prepaid amounts in relation to Microbiome Services that have not been performed by Us as at cancellation, We in Our absolute discretion may choose to either refund You such prepaid amounts **or** perform the outstanding Microbiome Services.

You acknowledge and agree that We may change Our Fees in relation to Your Subscription at any time. We will notify You of any changes to the Fees before they come into effect. If You do not agree with Our proposed Fee changes, You must cancel Your Subscription.

Your Subscription is not transferrable unless specifically authorised by Us. We may terminate Your Subscription with immediate effect if You fail to pay any Fees applicable to Your Subscription when due or where We suspect Your Subscription is being used in a way that was not intended by Us, and We will not be obliged to provide You with a refund with respect to such termination.

Microbiome Requests, Microbiome Services and Sample collection

Any User may submit a Microbiome Request. Upon receiving a Microbiome Request (as well as any additional consents We may require before We provide any Microbiome Services) and payment of the relevant Fees, We will send to You a Microba Sample Kit. Microba Sample Kits are subject to availability. We will not be liable for any delay in providing You with a Microba Sample Kit. Certain Microbiome Services may require more than one Sample over a period of time. We may decline to send a Microba Sample Kit for any reason upon receiving a Microbiome Request. If We do decline to send a Microba Sample Kit, We will refund payment of any relevant Fee.

You must collect, package and send the Sample to Us within 12 months of Us sending you a Microba Sample Kit. We will only accept Samples that have been sent to Us using the prescribed Microba Sample Kit and otherwise collected and packaged in accordance with Our instructions to You as set out in the Microba Sample Kit. Certain Microbiome Services may require more than one Sample over a period of time.

If you fail to provide us with a Sample within 12 months of Us sending you a Microba Sample Kit then you agree that We are not obliged to accept any Sample from You and that We shall not be liable to refund payment of any relevant Fee.

If You are a Participant in a Research Project, We may direct You to send Your Sample to Our Research Partner with respect to that Research Project. You agree and consent to Our Research Partner collecting, holding and disclosing Your Sample to Us in connection with the Research Project.

We are not obliged to provide You with a refund or replacement if You damage, misuse or misplace a Microba Sample Kit (for example, if You fail to follow Our instructions for Sample collection). If You require a replacement Microba Sample Kit due to damage, misuse or misplacement, We may charge You a replacement fee.

All Samples will be at Your risk until they are received by Us. We are not liable for any Samples damaged in the sampling process or lost or damaged in transit. In such circumstances, We in our absolute discretion may choose to either provide You with a new Microba Sample Kit for free or We may charge You a replacement fee (as determined by Us).

We will label each Microba Sample Kit with the details of the User that has submitted the Microbiome Request and is required to provide the Sample. You warrant that any Sample You send to Us or Our Research Partners contains only materials from that User's body and You irrevocably consent to Us carrying out Microbiome Services on that Sample. Where You have submitted a Microbiome Request for or on behalf of another person, You warrant and represent to Us that that person consents to Us carrying out Microbiome Services on that Sample and has read and understood these Terms.

It is acknowledged that Microba Pty Limited ABN 30 628 603 225 is the entity within Our group that will provide the Microbiome Services.

We will carry out the Microbiome Services using reasonable care and skill, however We make no guarantee that We will be able to successfully perform the Microbiome Services on Your Sample (for example, if Your Sample does not contain sufficient biological material or the results from our Services do not meet our standards for accuracy). If We determine in our absolute discretion that the Microbiome Services cannot be accurately and safely carried out on the Sample provided by You (**Failed Sample**), We will notify You and may request that You submit another Sample. In the event of a Failed Sample, We in our absolute discretion may choose to either provide you with a new Microba Sample Kit for free or We may charge you a replacement fee (as determined by Us).

We retain the right to make any changes to the Microbiome Services which are necessary to comply with any applicable law or safety requirement, or which do not materially affect the nature or quality of the Microbiome Services.

You acknowledge that we will not return any Sample to You. We may destroy, dispose and/or retain any Samples as we see fit depending on the nature of the issue and the type of Sample.

Unless You are a Participant in a Research Project, We will provide You with Your Microbiome Report as part of the Microbiome Services. If You are a Participant in a Research Project, You acknowledge that You will not receive the Microbiome Report with respect to Your Sample unless We or the relevant Research Partner has agreed otherwise. In any event, You agree that We may provide You with Your Microbiome Report online (in which case, You may access Your Microbiome Report by logging into Your account). We may agree to provide a hard-copy of Your Microbiome Report upon request, which may be subject to additional Fees.

Referral Codes

We may enter referral arrangements with certain third parties that provide health-related services to their patients or clients (**Insights Practitioners**). Under these arrangements, the Insights Practitioner may be given a unique referral code ("**Referral Code**"), which the Insights Practitioner can then provide to their patients or clients for their use in connection with the purchase of certain Microbiome Services.

You are not obliged to use a Referral Code to purchase Microbiome Services. If You have been provided with a Referral Code and You decide to use it in connection with the purchase of any Microbiome Services, You acknowledge, consent, and agree that:

- We may disclose a copy of the Microbiome Report We produce with respect to those Microbiome Services to the Insights Practitioner associated with that Referral Code and any of their associates or contractors that might be involved in providing health-related services to You (each, a "**Healthcare Provider**");
- We may disclose the Microbiome Report to the relevant Healthcare Provider via email, or otherwise allow them to view the Microbiome Report online; and
- We may hold a copy of the Microbiome Report, and We and Our personnel may hold, access and use the Microbiome Report, for the purposes of facilitating the delivery of the Microbiome Report to the relevant Healthcare Provider and assisting them to interpret the Microbiome Report.

You may withdraw this consent at any time by emailing Us at: info@microba.com.

While We endeavour to verify that Insights Practitioners (and any other person to whom We disclose Your Microbiome Report in accordance with this clause) are current registered health practitioners, You acknowledge that We do not, and are not obliged to, conduct background checks on Insights Practitioners (or any other person to whom We disclose Your Microbiome Report in accordance with this clause) or otherwise verify the information that they may provide.

Our recognition of a person as an Insights Practitioner in no way implies Our endorsement of that person, and should not be considered advice or a recommendation to engage in any relationship with that person (whether for health-related services or otherwise).

You agree that We are not responsible or liable for (and You release Us from) any damages or loss that may arise from:

- Your Microbiome Report being used or disclosed to a Healthcare Provider in accordance with this clause (Referral Codes);
- any act or omission by any Healthcare Provider (including with respect to the use, storage or disclosure of Your Microbiome Report or any other personal information); or
- any interaction You may have with any Healthcare Provider.

Information You provide to Us

Users will be required to send personal information to Us (including when submitting a Microbiome Request). Such information may include:

- personal information;
- health information;
- family health information and history;
- lifestyle information; and
- any other information that You provide to us (including when registering as a User or completing a Microbiome Request),

(User Information). You acknowledge that the Microbiome Services and/or Your participation in any Research Project is conditional upon You providing certain User Information.

We will use, store and handle User Information in accordance with the requirements of the *Privacy Act 1988* (Cth) and the Australian Privacy Principles that apply to Us and Our privacy policy which may be accessed at <https://www.microba.com/privacy-policy/>.

You consent to Us collecting, storing, using, and disclosing Your User Information and Your Microbiome Report (which may include Your personal information):

- to provide You with the Microbiome Services;
- if You are a Participant in a Research Project, for the purpose of carrying out the Research Project (as described in the applicable Participant Information Sheet); and
- otherwise in accordance with Our privacy policy, which applies to You and Your use of Microba at all times.

You further acknowledge that some of the User Information and the Microbiome Report may contain sensitive information for the purposes of the Australian Privacy Principles (including health information). You consent to our collection, storage, use, and disclosure of such information in accordance with Our privacy policy and these Terms.

Where relevant to the Microbiome Services We are providing to You, You further consent to Us disclosing to Australia Post certain personal information that You provide to Us (which may include Your email address, mobile phone details and/or your residential address) in connection with Us providing the Microbiome Services to You, and You acknowledge and agree that Australia Post may use such information for the purposes of providing notification of tracking events (and collecting any relevant feedback in relation to the delivery or tracking service). You may request that We delete Your personal information that We hold about You by sending Us an email at info@microba.com. Upon receiving this request, We will provide you with a form which must be signed and returned to Us so that we may process the request. You agree that any such request will only be effective from the point in time that We process Your request. You acknowledge that if We delete any of Your personal information then We may not be able to provide You with some or all of Our service.

Aggregated information

You agree and consent that:

- to the extent it is permitted or required by law; or
- where You have otherwise given Us Your express consent (which consent You may withdraw at any time online via Your registered account),

We may de-identify and aggregate User Information, Your Microbiome Report and any other results, data and other information generated, inputted or derived from performing the Microbiome Services, including by removing personal identifiers and removing or altering other information that may allow identification (**De-identified Data**). Without limitation, We may use such De-identified Data to conduct, publish and/or present research studies, and/or to develop diagnostics, therapeutics or other products/services. To the extent that De-identified Data is owned by You, you grant us an irrevocable perpetual, non-exclusive, assignable, worldwide and royalty free licence (with a right to sub-licence) to use and commercialise the De-identified Data for such purposes as we see fit. This right continues even if You no longer use Microba or are deregistered as a User.

You acknowledge that You acquire no rights in any research or commercial products that may be developed or derived by Us or Our licensees from any De-identified Data.

Research Data

If You are a Participant in a Research Project, You acknowledge that We will collect and generate Data from and in connection with the Research Project, including with respect to Your participation and the provision of the Microbiome Services to You (**Research Data**). This Research Data may include, without limitation, raw and analysed data, microorganism DNA sequence data, metagenome-assembled genomes (MAGs), genome metadata and survey metadata.

You acknowledge and agree that, to the extent permitted by law, the Research Data will be owned by Us. To the extent that title to any Research Data does not or cannot vest in, or be assigned to, Us, You grant to Us a perpetual, irrevocable, world-wide, non-exclusive, royalty free and fee-free licence (with a right to sub-licence and assign) to use that Research Data for the purposes set out in the applicable Participant Information Sheet and any other purposes that We see fit. You acknowledge that Our use of any Research Data may be subject to any agreement We may have with Our Research Partners.

You acknowledge that You will not acquire any rights in any works or research or commercial products that may be discovered, developed or derived by Us or Our licensees from any Research Data. All such rights are owned by Us or Our licensees (as the case may be).

Intellectual Property

We and our licensors (as applicable) own all Intellectual Property in Microba (including without limitation text, graphics, architecture and coding and any copyright subsisting in them). We own all trade marks, branding and logos contained in, or relating to, Microba and you cannot use them for any purpose without our express written consent.

Without limiting the above, all Intellectual Property rights in all Microbiome Reports are owned by Us. If We provide You with a Microbiome Report as part of the Microbiome Services, You may access and download Your Microbiome Report and may disclose such information to family and medical professionals for the purposes of obtaining medical advice, however You must not modify, publish, transmit, distribute, participate in the transfer or sale, create derivative works, or in any way exploit, Your Microbiome Report in whole or in part without Our prior written permission.

Outcomes and reliance on information

Nothing contained in any Microbiome Report or on Our Website should be construed as medical advice. Any information We provide to You (including information set out in Your Microbiome Report or on Our Website) is provided on an “as is” basis for general

information only and must not be considered professional medical advice or a recommendation. You must not rely on such information and should not make any decisions in reliance on such information.

We are not a medical or health provider and the Microbiome Services are not supported by clinical verification. Any information We provide (including any Microbiome Report) is not intended to diagnose conditions nor prescribe the use of any remedy, diet or lifestyle practice. We will not diagnose, treat or prevent any condition or disease. While we provide information and perform the Microbiome Services, we do not give medical advice and any concerns You might have should be directed to Your health care practitioner. Any and all information We provide to You (including any information set out in any Microbiome Report) must not be considered a substitute for medical advice or a doctor's consultation, evaluation or treatment, and You should discuss any information set out in Your Microbiome Report with a medical professional. You accept liability for any decision made (or not made) or action taken (or not taken) in reliance on any information contained or omitted from Your Microbiome Report. You must not disregard professional advice, or delay seeking it, because of any information contained in Your Microbiome Report.

Microbiome Coaching Services and third-party service providers

We may offer You Microbiome Coaching Services as part of the Microbiome Services or in connection with Your participation in any Research Project. As part of such Microbiome Coaching Services, You agree that We and Our personnel may access and use Your User Information and Microbiome Report for the purpose of discussing the Microbiome Report and Our services with You (whether via online screen sharing or otherwise).

Our Fees for such Microbiome Coaching Services (if any) will be set out on Our Website or as otherwise notified by Us. Any information provided to you through the Microbiome Coaching Services is for your general information and use only and must not be considered a substitute for medical advice. We will not diagnose conditions as part of Our Microbiome Coaching Services.

We may also provide details of preferred external service providers from time to time (including dietitians and doctors). We only provide such details for User convenience and do not specifically endorse any external service provider, organisation, association or entity referred to in, or linked to, Our Website. It is your responsibility to make your own decisions about what health care professional or other external service provider You use. You acknowledge that we may have commercial cross-referral agreements in place with external service providers from time to time.

Advertisement information and cookies on Our Website

We may allow certain third parties to post information (including advertisements or promotions) on the Website. We are not responsible for any incorrect, inaccurate, incomplete or unreliable information provided by such third parties. You are solely responsible for relying on any such information. You may not copy, duplicate, distribute, display, sell, translate, publish, transmit or modify any such information without express consent from Us.

Advertisements displayed on the Website may set cookies. These cookies, which are industry standard and used by most websites, allow the ad server to recognise Your computer each time they send You an online advertisement to compile non-personal identification information about You or others who use Your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to You. If You do not want information to be collected through the use of cookies, there is a simple procedure in most browsers that allows You to deny or accept the cookie feature. But please be aware that denying the cookie feature may prevent You from taking full advantage of the Website.

External sites

In using Microba, You may come across links or references to external merchants or suppliers. Please be aware that We do not make any promises about what they may supply to You. Therefore, any transaction You have with these merchants are between You and

these merchants, and We do not get involved. By accessing external Website links to these merchants and other sites through Microba, We do not promise that they are appropriate, that they work or that they are virus free. We accept no responsibility for them or for any loss or damage that may arise from Your use of them.

Access to Microba

We reserve the right to suspend, withdraw, discontinue or amend all or any part of Microba without notice. We will not be liable if, for any reason, Microba is unavailable at any time or for any period. From time to time, We may restrict access to all or any part of Microba. You are responsible for making all arrangements necessary for You to have access to the Website. You are also responsible for ensuring that all persons who access the Website through Your internet connection are aware of these Terms, and that they comply with them.

Unauthorised access or use of Microba may give rise to a claim for damages and/or be a criminal offence.

Changes to Microba and its availability

We may change or improve Microba at any time. We may also stop making Microba available or modify its availability in any way. We are under no obligation to update any material that may be out of date at any given point in time.

We will always try to give You notice of any significant changes to Microba or its availability before such changes take effect, although this may not always be possible. To the maximum extent permitted by law, We do not accept liability for any damage or loss which You may suffer or incur as a result of such changes.

Prohibited uses

You agree that You will only use Microba for lawful purposes. If You send or post information on or using Microba, You are responsible for anything You send or post. You must not send or post anything that is offensive; infringes any person's rights; is against any applicable law; or which We think is inappropriate.

You must ensure that Your access to and use of Microba is not illegal or prohibited by any laws which apply to You. By participating in any Research Project or otherwise using Microba, You represent and warrant that You will not:

- infringe the rights of any other person, including without limitation any Intellectual Property rights;
- defame another person;
- provide false information, misleading or inaccurate information to Us or any other User;
- impersonate, or otherwise misrepresent affiliation, connection or association with, any person or entity;
- disclose another person's confidential information or otherwise contravene Your privacy obligations or any other person's privacy obligations;
- use or attempt to use any engine, software, tool, agent, or other device or mechanism (including without limitation browsers, spiders, robots, avatars, or intelligent agents) to harvest or otherwise collect information from Microba for any purpose, including without limitation use on third-party websites;
- attempt to probe, scan, or test the vulnerability of Microba or any associated system or network, or breach security or authentication measures without proper authorisation;
- threaten, offend or abuse Us or another User; or
- do any which is otherwise, in Our view, inappropriate or harmful to Microba.

Promotions and voucher codes

We may offer and distribute voucher codes from time to time. A **voucher code** is a code that must be entered at checkout on transactions for certain Microbiome Services in order to receive a discount or other benefit as determined by Us. Each voucher code is subject to these Terms and any other specific terms and conditions as set out by Us in relation to the voucher code offer (for example on our Website or otherwise notified by Us to You). Voucher codes are not redeemable for cash, are valid for qualifying purchases only (as determined by Us) and must be redeemed within the validity period. Unless stated otherwise, voucher codes may only be used once. We do not accept any liability for lost voucher codes. Voucher codes are not transferable unless specifically authorised by Us. We reserve the right in Our absolute discretion to refuse any voucher code (or to otherwise refuse to provide any Microbiome Services associated with any voucher code) where We suspect the voucher code has been leaked, stolen or misused or the voucher code has expired.

Security and integrity

You must not violate the security of Microba in any way. We may suspend or cancel Your account and Your access to Microba, or otherwise terminate Your participation in any Research Project, if We suspect any security violation. We may also inform any law enforcement body of any suspected unauthorised or criminal activity. Examples of security violations include:

- attempting to gain unauthorised access to any part of Our servers or system infrastructure You were not intended to have access to;
- use Microba in a way that was not intended by Us;
- attempting to reverse engineer Microba or any system or offering provided through it;
- interfering with or disrupting (or attempting to interfere or disrupt) any servers or networks connected to Microba;
- sending or storing any harmful code (including, for example, any computer virus, trojan, worm or other code that is harmful or disabling or which assists in or enables unauthorised access to or corruption of data); or
- using any feature of Microba or any other means to send unsolicited commercial correspondence to other Users.

Disclaimer of warranties

By participating in any Research Project, accessing our Website or otherwise using Microba, to the extent permitted by law You assume all risks associated with such participation, access and use.

The Microbiome Services are subject to continuing research, clinical experience, reasonable differences in opinions among authorities, unique aspects of individual situations and the possibility of human error. We cannot promise or guarantee any specific outcomes from Your use of Microba or Your participation in any Research Project. To the extent permitted by law, no representation or warranty (express or implied) is made:

- as to the outcomes, currency, completeness, accuracy, reliability, suitability, and/or availability of Microba, any Research Project, the Microbiome Services or Your Microbiome Report (if any); and
- that Microba, the Microbiome Services or Your Microbiome Report (if any) will meet your health or medical requirements.

Limitation of liability

Without limiting the above, to the extent permitted by law (including the Australian Consumer Law), any liability we do owe (including any liability for failure to comply with consumer guarantees required by the Australian Consumer Law) is limited to the amount you paid to use Microba, or (if we choose) us providing the service or product again.

Indemnity and release

You agree to indemnify Us (and Our directors, employees and agents) from and against all claims, liabilities, losses and expenses (including reasonable legal fees on a full indemnity basis) that arise from:

- any reliance on any information We provide to You;

- any breach of these Terms by You;
- any breach of any rights of a third party by You; or

Changes to and breaches of these terms

You submit to the jurisdiction of the courts of Queensland, Australia in respect of any claim arising from, or related to, these Terms, although We reserve the right to bring proceedings against You for breach of these Terms in Your country of residence or any other relevant jurisdiction.

Severance
